

But the even closer connection is that Carter was a close friend and partner in humanitarian work with LeRoy Troyer, the Mennonite architect who designed our church building. # URGENT ACTION: tell Senate "NO money for ICE murders!"

---

We've all been watching as ICE has brutalized our immigrant communities and murdered those bearing witness in Minneapolis. As Mennonites, we must speak up. This week- as soon as Tuesday – the Senate will vote on the DHS appropriations bill that has already passed in the House. This means we have a small window to enact meaningful change: stop any increase in funding for ICE. As constituents, it's critical we call upon our Senators and demand they refuse to vote for any appropriations bill that continues to fund the Department of Homeland Security and ICE. The recent killings of Renee Good, Alex Pretti, Silverio Villegas González, and Keith Porter Jr. have been horrifying to watch unfold. But even before these deaths, ICE has facilitated the deaths of migrants held in detention centers, disappeared our neighbors, and created fear and chaos in the lives of our immigrant neighbors. The recent killing of American citizens is a new chapter in a long history of state violence and brutality, primarily leveraged against black and brown people. We see ICE as an extension of the same violence that's claimed tens of thousands of lives in Gaza over the past two years. From Palestine to Minneapolis, authoritarian power asserts violence and subjugation over those created in the image of God – but Jesus stands on the side of the oppressed. Thank you for joining us in this urgent ask. In these dark days, we carry one another.

## TO CALL:

Click [here](#) to find your Senators. Call both their federal and state offices and call often. Use the provided call script:

*Hello my name is \_\_\_\_\_ and I am a Mennonite Christian constituent of yours living in [place] at [zip code]. I'm calling to urge Senator [Name] to refuse to vote for any appropriations bill that continues to fund the Department of Homeland Security and ICE. The killings of Renee Good, Alex Pretti, Silverio Villegas González, Keith Porter Jr. and the numerous deaths in ICE detention facilities are part of a broader pattern of unchecked violence, impunity, and abuse carried out by federal immigration enforcement agencies against our communities. As a person of faith I am compelled to bear witness and love my neighbor. And I cannot remain silent as our neighbors are kidnapped, beaten, and murdered by federal agents. We have no time to wait, Senator [Name] must vote no this week and say 'No more money for ICE.'*

*Solar cookers shine a light on sustainable alternative to gas, electric and wood ovens.*  
It's impossible to pass Peter and Mary Sprunger-Froese's house in Colorado Springs, Colo., without noticing the large yellow contraption resembling a homemade telescope in the front yard. On closer inspection, a lucky passerby might discover a batch of cookies bubbling in the insulated box at the center of the dish. Instead of radio waves, the reflective panels of this solar oven concentrate sunlight for baking food. "We leave the oven outdoors in front of the house all the time," Mary said. ## Vastria detention centre: a new Environmental Impact Assessment recycles old problems – and introduces new ones

Now nearing completion on the island of Lesvos, the Vastria Closed Controlled Access Centre – essentially a prison for people on the move – embodies the shift of both the Greek state and the European Commission towards increased control. Vastria CCAC is located in the middle of a pine forest at enormous risk of wildfires, posing serious danger to the lives and safety of a potential 5,000 detainees. [As we have already warned](#), for over four years the Greek Ministry of Migration and Asylum has bypassed environmental protections, ignored local opposition, and sidestepped legal rulings through piecemeal amendments and technical redesigns. The opening of Vastria has been delayed over, among other things, a failure to allow full public consultation during a previous Environmental Impact Assessment (EIA), which was in any case inaccurate and misleading. Following legal appeals against it, the EIA was eventually withdrawn. The move was considered a procedural evasion ahead of an upcoming annulment hearing by the Council of State. **Read the rest of CPT Aegean Migrant Solidarity's article published by Community Peacemaker Teams [here](#).**

## We Cannot Stand Aside

The CPT Iraqi Kurdistan team joins the call for solidarity with the people of Rojava. Two members of the CPT team, together with a group of civil rights activists and independent journalists from Slêmanî, travel to North-East Syria to provide international presence and solidarity with the Kurdish-led civilian resistance and the defense of life. For over 20 years, CPT has accompanied civil rights defenders and nonviolent resistance in the face of Turkish and other foreign military attacks in South Kurdistan and Iraq. Today, as the hard-won autonomy of Rojava and the rights and lives of its people face an existential threat—amid mounting fears of ethnic cleansing and other mass atrocities—the CPT team has decided it cannot stand aside. Across Kurdistan, people are experiencing a profound sense of betrayal by Western governments that once supported the administration of Rojava. These governments have now largely abandoned it, choosing instead to support and normalize relations with the current Syrian regime under the false pretext of a “unified Syria.” **Read the rest of the Community Peacemaker Teams press release [here](#).**


